Education:

- WCSU Literacy Initiative Teachers are researching and eventually ordering F&P leveled books with funds appropriated by WCSU.
- Vermont Energy in Education Program (VEEP) Mrs. Simonds will once again lead the school in a
  "Whole School Energy Challenge" this winter beginning in January. The Woodstock Endowment
  Fund granted KES funding for Energy Week, which will take place at the end of March.
- Afterschool Program Numbers have not evenly increased since soccer season ended, with most people attending on Thursday.
- English Language Learner Teacher Dale Pfeifenberger has taken on the role of ELL Coach under the direction of Glenna Coleman.
- Strong turnout for Trailblazers volunteer meeting. Thank you to Randy Wood for taking on the never-evers this year!
- Holiday Events KES performs at the Festival of Trees December 4th at 4:30 PM under the
  direction of Christine Morton; Lisa Kaija and KES art students are making decorations for the
  Killington tree; Killington Rec. is tentatively planning a holiday dance on Dec. 4th at 7 PM in the
  cafeteria
- Special Education Needs It is evident and anticipated that a 1:1 aide is necessary for a KES student beginning December 14, 2015, for the remainder of the school year and subsequent years.

## **Business:**

- Enrollment: K-6 91; Preschool 13; up to 16 by Dec. 1
  - o Tuition students 36
- Transportation Behaviors have been more manageable on the bus lately after several assigned seating arrangements. Seatbelts have been removed from the bus.

- Edgemont Owners' Associate donated \$100. The association used the gym for their annual meeting in October.
- Safety: Fire Marshall inspected on 10/30/15. Sent reminders on use of extension cords and door chocks, and surge protectors. Coat room doors need to be self-closing and latching. Dave Cleaves has repaired this violation, well within the 30-day window.
- Buildings & Grounds: Dave Cleaves has researched options for snowblowers. The 20-year old snowblower at KES will require more than \$600 in repairs. A new snowblower will cost \$2,370.65 through Mountain View. It is proposed that a new Honda snowblower be purchased this winter.
